

PRIVACY NOTICE FOR US RESIDENTS

Effective Date: April 1, 2023

This Privacy Notice for US Residents (the “**Notice**”) supplements the information contained in the [Privacy Policy](#) of Novakid Inc. (the “**Company**” or “**Novakid**”) and applies solely to all visitors, users, and others who reside in the United States (“**User**” or “**you**”). We adopt this Notice to comply with the California Consumer Privacy Act of 2018 (CCPA), the California Privacy Rights Act of 2020 (CPRA), the Virginia Consumer Data Protection Act and other state laws . Any terms defined in the privacy laws of the United States have the same meaning when used in this Notice.

This Notice does not apply to employment-related personal information which may be collected from US-based employees, job applicants, contractors, or similar individuals. Where noted in this Notice, the CCPA temporarily exempts personal information reflecting a written or verbal business-to-business communication (“**B2B personal information**”) from some of its requirements.

1. INFORMATION WE COLLECT

We collect information that identifies, relates to, describes, references, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer, household, or device (“**personal information**”). Personal information does not include:

- Publicly available information from government records.
- Deidentified or aggregated consumer information.
- Information excluded from the CCPA's scope, like:
 - a. health or medical information covered by the Health Insurance Portability and Accountability Act of 1996 (HIPAA) and the California Confidentiality of Medical Information Act (CMIA) or clinical trial data;
 - a. personal information covered by certain sector-specific privacy laws, including the Fair Credit Reporting Act (FCRA), the Gramm-Leach-Bliley Act (GLBA) or California Financial Information Privacy Act (FIPA), and the Driver's Privacy Protection Act of 1994.

We have collected the following categories of information from users in the past twelve (12) months and we also expect to collect them in the future:

We obtain the categories of personal information listed above from the following categories of sources:

- Directly from you. For example, when you create an account to access or utilize our Services.
- Indirectly from you. For example, behavior data collected when you use or utilize our Services.
- Directly and indirectly from activity on our Website. For example, from submissions through our website portal or website usage details collected automatically.
- From third-parties that interact with us in connection with the Services we perform.

2. USE OF PERSONAL INFORMATION

During the last 12 months, we may have used or disclosed the personal information we collect for the following business or commercial purposes:

- To fulfill or meet the reason you provided the information. For example, if you share your name and contact information to ask a question about our products or services, we will use that personal information to respond to your inquiry. If you provide your personal information to purchase a product or

service, we will use that information to process your payment and facilitate delivery. We may also save your information to facilitate new product orders or process returns.

- To provide, support, personalize, and develop our Services.
- To create, maintain, customize, and secure your Account with us.
- To process your requests, purchases, transactions, and payments and prevent transactional fraud.
- To provide you with support and to respond to your inquiries, including to investigate and address your concerns and monitor and improve our responses.
- To personalize our service experience and to deliver content and product and service offerings relevant to your interests, including targeted offers and ads through our Services, third-party sites, and via email or text message (with your consent, where required by law).
- To help maintain the safety, security, and integrity of our Services, the related databases and other technology assets, and business.
- For testing, research, analysis, and product development, including to develop and improve our Services.
- To respond to law enforcement requests and as required by applicable law, court order, or governmental regulations.
- As described to you when collecting your personal information or as otherwise set forth in the CCPA.
- To evaluate or conduct a merger, divestiture, restructuring, reorganization, dissolution, or other sale or transfer of some or all of our assets, whether as a going concern or as part of bankruptcy, liquidation, or similar proceeding, in which personal information held by us about our Users is among the assets transferred.

We will not collect additional categories of personal information or use the personal information we collected for materially different, unrelated, or incompatible purposes without providing you notice.

3. SHARING PERSONAL INFORMATION

We may disclose your personal information to a third party for a business purpose as described in Section 6 of [Privacy Policy](#). When we disclose personal information for a business purpose, we enter a contract that describes the purpose and requires the recipient to both keep that personal information confidential and not use it for any purpose except performing the contract. The CCPA prohibits third parties who purchase the personal information we hold from reselling it unless you have received explicit notice and an opportunity to opt-out of further sales.

We share your personal information with the third parties that may include:

- Payment service providers;
- Cloud service providers;
- Software development tool and cloud services providers;
- Marketing partners;
- Customer support services providers;
- Learning services providers;
- Professional advisers, including consultants, accountants, auditors, solicitors. including without limitation Google Analytics (for usage analytics), Yandex and any third-party payment processors and fulfillment service providers.

We do not sell your personal information in exchange for monetary compensation. We may share your personal information by allowing certain third parties to collect your personal information via automated technologies on our Services for cross-context behavioral advertising purposes. This kind of sharing may be considered a “sale” under the CCPA/CPRA when the personal information is exchanged for non-monetary consideration. You have the right to opt out of these types of disclosures of your information. We do not sell or share sensitive personal information.

In addition to the categories of third parties identified above, during the 12-month period prior to the effective date of this Policy, we may have disclosed personal information about you to the following additional categories of third parties: governmental entities and third parties in connection with corporate transactions (e.g., mergers, acquisitions, joint venture, reorganization, divestitures, dissolution or liquidation).

4. YOUR RIGHTS

The California Consumer Privacy Act of 2018 (“CCPA”), as amended by the California Privacy Rights Act of 2020, effective January 1, 2023 (“CPRA”) and some other state privacy laws provide consumers with specific rights regarding their personal information. This section describes your rights and explains how to exercise those rights.

(1) Right to know what information we collect. Right to access.

You have a right to request that we disclose to you the categories of personal information we collected about you; the categories of sources from which we collect personal information; purpose for collecting, using or selling personal information; the categories of third parties with whom we share that personal information; the specific pieces of personal information we collected about you over the past 12 (twelve) months.

(2) Right to delete personal information.

You have a right to request that we delete any of your personal information that we collected from you and retained, subject to certain exceptions. Once we receive and confirm your verifiable consumer request, we will delete (and direct our service providers to delete) your personal information from our records, unless an exception applies. If we cannot delete your personal information, we will give you a reason why we cannot do so.

We may deny your deletion request if retaining the information is necessary for us or our service provider(s) to:

- Complete the transaction for which the personal information was collected, fulfill the terms of a written warranty or product recall conducted in accordance with federal law, provide a good or service requested by the consumer, or reasonably anticipated by the consumer within the context of a business’ ongoing business relationship with the consumer, or otherwise perform a contract between the business and the consumer.
- Help to ensure security and integrity to the extent the use of the consumer’s personal information is reasonably necessary and proportionate for those purposes.
- Debug to identify and repair errors that impair existing intended functionality.
- Exercise free speech, ensure the right of another consumer to exercise that consumer’s right of free speech, or exercise another right provided for by law.
- Comply with the California Electronic Communications Privacy Act pursuant to Chapter 3.6 (commencing with Section 1546) of Title 12 of Part 2 of the Penal Code.

- Engage in public or peer-reviewed scientific, historical, or statistical research that conforms or adheres to all other applicable ethics and privacy laws, when the business' deletion of the information is likely to render impossible or seriously impair the ability to complete such research, if the consumer has provided informed consent.

- To enable solely internal uses that are reasonably aligned with the expectations of the consumer based on the consumer's relationship with the business and compatible with the context in which the consumer provided the information.

- Comply with a legal obligation.

(3) Right to opt-out of sale or sharing of personal information.

We do not sell the personal information of Users, as indicated in the CCPA or other applicable state privacy laws, including of those we actually know are less than 16 years of age. For the purpose of this Notice, "sell" means the sale of your personal information to an outside party for monetary or other valuable consideration, subject to certain exceptions in the CCPA and other applicable state privacy laws. Since we do not sell your personal information, you do not have to go through steps to opt-out or opt into the sale of your information.

(4) Right to correct inaccurate personal information.

You have the right to request that we correct the personal information we maintain about you if that information is inaccurate.

(5) Right to limit use and disclosure of sensitive personal information.

This right is limited to sensitive personal information for the purpose of inferring characteristics about an individual. We do not collect sensitive personal information nor do we use sensitive personal information for the purpose of inferring characteristics about the users that we hold about that individual.

California "Shine the Light" Disclosures.

Pursuant to California Civil Code Section 1798.83(c)(2), California law requires us to inform California residents who have provided us with personal information that they may request information from us about our disclosures to third parties for their direct marketing purposes. Disclosure for Nevada residents.

Nevada law (NRS 603A.340) requires each business to establish a designated request address where Nevada consumers may submit requests directing the business not to sell certain kinds of personal information that the business has collected or will collect about the consumer.

A "sale" under Nevada law is the exchange of personal information for monetary consideration by the business to a third party for the third party to license or sell the personal information to other third parties. Please note, that we do not "sell" any part of your personal information.

Disclosure for Virginia residents.

Virginia provides additional rights to Virginia residents through the Virginia Consumer Data Protection Act ("VCDPA"). This section addresses those rights and applies only to Virginia residents acting in an individual or household context.

In accordance with the VCDPA, Virginia residents have the following rights:

- to confirm whether or not we are processing your personal data and to access such personal data;

- to correct inaccuracies in your personal data, taking into account the nature of the personal data and the purposes of the processing of your personal data;
- to delete personal data provided by or obtained about you;
- to obtain a copy of your personal data previously provided to us in a portable and, to the extent technically feasible, readily usable format;
- to opt-out of the processing of the personal data for purposes of (i) targeted advertising, (ii) the sale of personal data, or (iii) profiling in furtherance of decisions that produce legal or similarly significant effects concerning you.

5. EXERCISING ACCESS, DATA PORTABILITY, AND DELETION RIGHTS

To exercise the access, data portability, and deletion rights described above, please submit a verifiable consumer request to us by emailing us at: support@novakidschool.com.

Only you, or someone legally authorized to act on your behalf, may make a verifiable consumer request related to your personal information. You may also make a verifiable consumer request on behalf of your minor child.

You may only make a verifiable consumer request for access or data portability twice within a 12-month period.

The verifiable consumer request must:

- Provide sufficient information that allows us to reasonably verify you are the person about whom we collected personal information or an authorized representative, which may include:
 - First Name, Last Name, Email used to register with the Company, and Phone Number
- Describe your request with sufficient detail that allows us to properly understand, evaluate, and respond to it.

We cannot respond to your request or provide you with personal information if we cannot verify your identity or authority to make the request and confirm the personal information relates to you.

Making a verifiable consumer request does not require you to create an account with us. However, we do consider requests made through your password protected account sufficiently verified when the request relates to personal information associated with that specific account.

We will only use personal information provided in a verifiable consumer request to verify the requestor's identity or authority to make the request.

6. RESPONSE TIMING AND FORMAT

We endeavor to respond to a verifiable consumer request within 45 days of its receipt. If we require more time (up to 90 days), we will inform you of the reason and extension period in writing. If you have an account with us, we will deliver our written response to that account. If you do not have an account with us, we will deliver our written response by mail or electronically, at your option. Any disclosures we provide will only cover the 12-month period preceding the verifiable consumer request's receipt. The response we provide will also explain the reasons we cannot comply with a request, if applicable.

For data portability requests, we will select a format to provide your personal information that is readily useable and should allow you to transmit the information from one entity to another entity without hindrance.

We do not charge a fee to process or respond to your verifiable consumer request unless it is excessive, repetitive, or manifestly unfounded. If we determine that the request warrants a fee, we will tell you why we made that decision and provide you with a cost estimate before completing your request.

7. NON-DISCRIMINATION

We will not discriminate against you for exercising any of your CCPA rights. Unless permitted by the CCPA, we will not:

- Deny you goods or services.
- Charge you different prices or rates for goods or services, including through granting discounts or other benefits, or imposing penalties.
- Provide you a different level or quality of goods or services.
- Suggest that you may receive a different price or rate for goods or services or a different level or quality of goods or services.

8. RETENTION PERIOD

We retain each category of personal information for the length of time that is reasonably necessary for the purpose for which it was collected, and as necessary to comply with our legal obligations, resolve disputes, prevent fraud, and enforce our agreements.

9. CHANGES TO OUR PRIVACY NOTICE

We reserve the right to amend this privacy notice at our discretion and at any time. When we make changes to this privacy notice, we will post the updated notice on our website and update the notice's effective date. **Your continued use of our Services following the posting of changes constitutes your acceptance of such changes.**
